To The Manufacturer Representative
MICHELIN – Mr Michel Demolin

The Stewards, having received a report from the Technical Delegate, having summoned the manufacturer representative (Log n°2, Summons n°1), hearing the manufacturer representative Mr Michel Demolin in presence with the ELMS Technical Delegate David Hache, and having considered the following matter, determine that a breach of the regulations has been committed by the event participant named below and impose the penalty referred to.

Competition participant MICHELIN represented by Mr Michel Demolin
Session Before scrutineering

Facts Did not declare the tyres references to the Technical Delegate 48 hours before the event

Offence Breach of Art 7.7.4 of 2019 ELMS Sporting Regulations.

Penalty **Fine € 11.000 for Monza event payable as follows:**
€ 1000 with immediate and definitive effect
€ 10.000 suspended until the end of the 2019 ELMS season
The suspension shall be revoked for another declaration infringement by the tyre manufacturer until the end of the 2019 ELMS season.


Reason The representative of Michelin sent a first list of tyres eligible on time (6th May at 18:36) but with mistakes discovered by a competitor. He agreed with the report of the Technical Delegate that the final list of tyres eligible for the competition 4 Hours of Monza, starting on 09th May 2019, has been declared on 09th May 2019 at 11:42am. The late declaration delayed the planned schedule of scrutineering and the scanning of the tyres by the scrutineers. In accordance with art 1.3 ELMS Sporting Regulations and art 1.3 International Sporting Code, Michelin is considered as a Participant of the competition and undertake himself to the decisions of the Sporting Authority.


The Participant is reminded of his right of appeal under and in compliance with Art.4.10.2 of the 2019 ELMS Sporting Regulations, and Art.15 of the International Sporting Code.

We remind you that it has to be paid to the LMEM 48 hours as from the present notification.
