From	The Stewards of the Meeting	Decision N° 1
To	The Manufacturer's Representative DUQUEINE Automotive	

The Stewards, having received a report from the Technical Delegate (report No.1) and having heard the manufacturer's representative Mr. Max Favard in presence with technical Delegate David Hache and the ACO representative Clément Hugon, determined that a breach of the regulations has been committed by the manufacturer named below and impose the penalty referred to.

**Competition participants** DUQUEINE Automotive

**Facts** Supply of set-up documents (Technical Bulletin 15.) prescribing non-legal configurations to customers (art.1.2.2. and 1.3.4. ELMS sporting regulations, art. 3.1. and 3.6.2 of the LMP3 technical Regulations)

**Offence** Breach of Article 12.2.1.c. of the FIA ISC

**Penalty** 5 000€ payable with immediate and definitive effect  
20 000€ suspended to the issuance by Duqueine Automotive of an amended versions of their Technical Bulletin n° "TECH\_15" and of the set-up sheet for the Competition in compliance with the Technical Regulations of the Series, at the latest 8pm on 22/10/2021 and not repeat a similar offence until the end of the season.

**Reasons** The Stewards consider DUQUEINE Automotive as participant of the competition (Art.1.3.4. of the ELMS Sporting Regulations)  
The Stewards, having heard the Technical Delegate, acknowledge that the breaches reported concern the documents issued by Duqueine Automotive. These prescriptions are contrary to the wording of the regulations and constitute a clear indication from the chassis manufacturers to implement modifications to the car which are not allowed under Article 3.6.2 and 3.1 of the LMP3 Technical Regulations. The representative of the manufacturer agreed this Technical Bulletin No.15 was not giving the proper information to the competitors. The opinion of the Stewards is that the penalty must be imposed on the DUQUEINE Automotive rather than on Competitors.

The Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with the Art.15 of the FIA International Sporting Code, within the applicable time limits.
