**Description:** PROTEST lodged by The Competitor of car No. 34 TF SPORT Against the Competitor of car No. 83 AF CORSE

### Procedure:

- 1. On Sunday 24th September 2023, the Race director at 16.00 hrs a protest lodged by the Competitor of car No. 34 addressed to the Stewards of 2023 ELMS Race in Spa-Francorchamps.
- 2. The protest was accompanied with a cash deposit of € 700.
- 3. Competitor No. 34 stated in his protest that the protest was against car 83 during the FCY at the end of the race. He describes a situation where, after the green light, car 83 had already accelerated and overtaken car 34. Parties present at the Hearing:
- 6. The hearing was held on Sunday 23rd September 2023 at 18:45 hrs in the Stewards' Room with all Stewards present. The hearing was also attended by Ms. Simonetta Manara and Julien Habbouche, (Secretaries of the Race)

### Decision:

- 8. The Stewards examined the admissibility of the protest:
- 9. The protest was lodged in due time, in accordance with Art. 13.3 of the 2023 FIA International Sporting Code, actual time of publication: 15.47hrs).
- 10. The protest was lodged by a single competitor against a single competitor as stipulated in the 2023 FIA International Sporting Code Art. 13.1.1 to 13.1.3 and Art. 13.7. 13. The protest does not specify the relevant regulations and article of the regulations.
- 11. The protest was properly accompanied by the protest deposit of € 700, as stipulated in Art. Appendix 1 of 2023 ELMS Spa Event Supplementary Regulations.

- 12. The protest does not specify the relevant regulations and article of the regulations. As a result The Stewards consider that the protest is not admissible and that the requirements of the Code have not been complied with.
- 13. The protest fee will not be returned to Competitor No. 34.

The Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with the Art.15 of the FIA International Sporting Code, within the applicable time limits.
